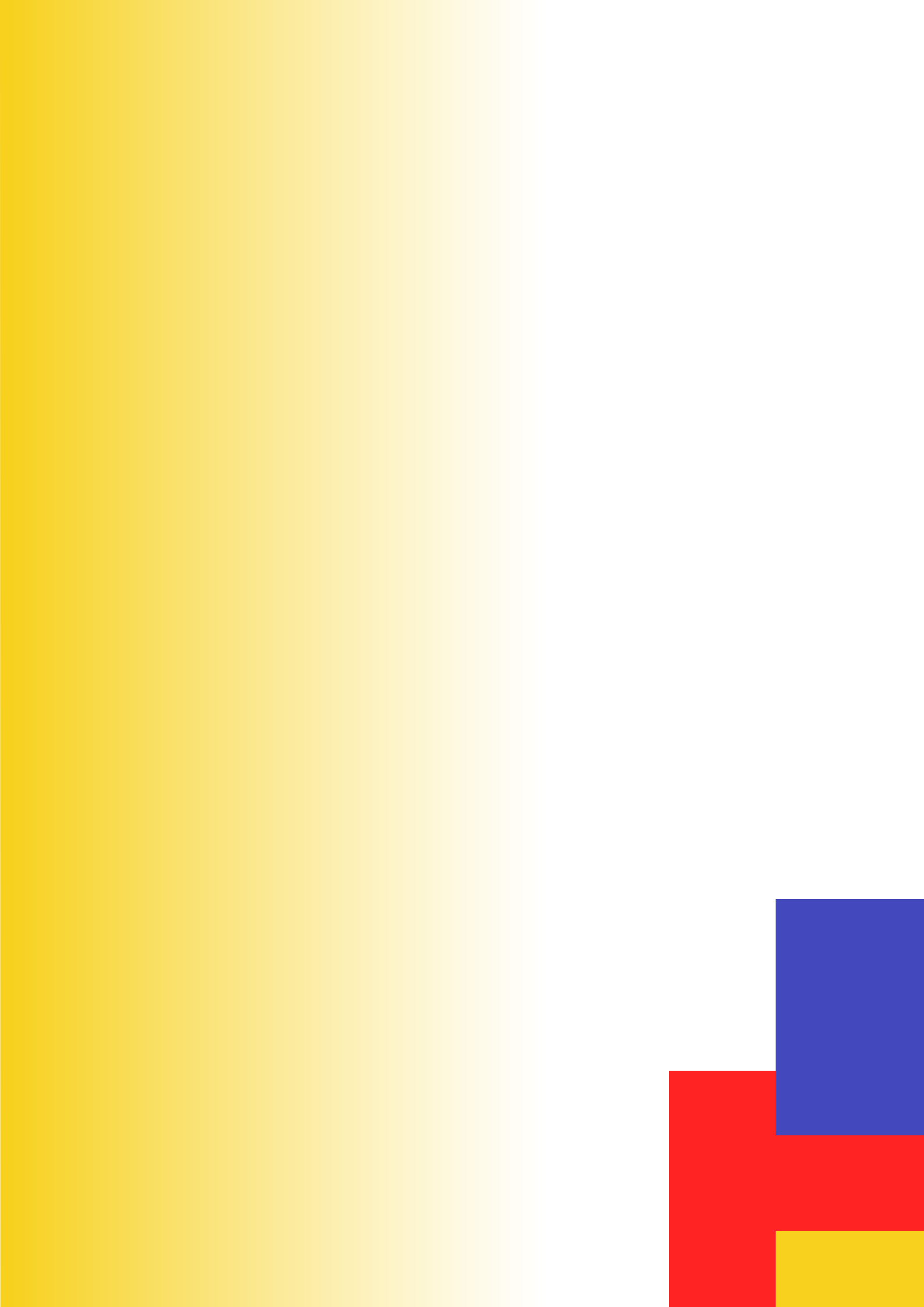

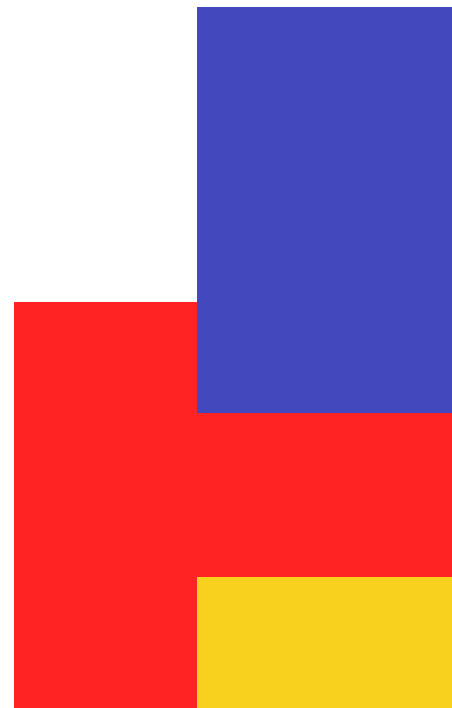
Presentation

Issues of migration have been at the heart of European debates for many years. From the Arab Spring to the refugee crisis of 2015, the countless crises that swept across European borders transformed Europe into an increasingly hostile environment for migrants and refugees.

Member States built walls to protect external borders and adopted ever more stringent measures to further restrict access to the right of asylum. It is within this troublesome context that new and heterogeneous social movements began, made up of legal aid grassroots initiatives, activists, academics, NGOs, dedicated to strengthening and supporting the rights of migrants and refugees.

This free, online training programme is designed to help young European activists become involved in, and make a difference to, support and solidarity projects with migrants and asylum seekers.

The programme is led by an international pool of law professors, activists, lawyers and project managers, all of whom have many years of experience in, and a long-standing commitment to, the field of protection of migrants' rights.



The training programme is divided in 3 modules:

Module I. Eu migration legal framework on the field

The module explores European migration and asylum law and offers a strong foundational understanding of the legal skills and practical strategies needed for the protection of migrants' and refugees' rights at the EU level.

N. of hours: (18 hours - 9 online lessons)

When: mid-October 2022 to mid-November 2022

Lesson 2 : The EU asylum system. Case study: The Ukrainian Crisis

Lesson 3: Inside Dublin: rules, criteria, exceptions, and remedies

Lesson 4: Intersectionality: a gender perspective on asylum

Lesson 5: Seeking asylum in the climate crisis

Lesson 6: Sans-papier: the Return Directive and the criminalization of solidarity

Lesson 7: The right to be together. The family reunification rules

Lesson 8: The ECHR: functions and case studies


Lesson 9: In Europe: Legal framework of intra-European mobility of migrants

Module II. Practicing Legal Aid: national focuses and transnational issues

The module analyzes differences, shared features, and specific tools for the protection of migrants' and refugees' rights in selected Member States. Thematic round tables will offer in-depth analysis of specific topics of particular relevance in today's Europe as a borderland.

N. of hours: (14 hours - 7 online lessons)

When: mid-November 2022 - early December 2022

Lesson 2: The Arraigo Social and the condition of irregular migrants in Spain

Module III-Taking action: activism and lawyering experiences and tools

Drawing from the direct experience of activists working with European grassroots organizations, this module offers basic training in project design, management and fundraising for solidarity grassroots initiatives including case studies from ongoing projects in legal support and solidarity with migrants and asylum seekers.

N. of hours: (12 hours - 6 online lessons)

When: mid-December 2022 - mid January 2023 (with a Christmas holiday break)

Lesson 2: The moveurope! programme: intra-European mobility for young people with refugee backgrounds

Course Objectives

Through concrete examples drawn from solidarity projects, the training programme will give participants:

1. The know-how to create new grassroots initiatives;
2. Networking opportunities among grassroots organizations from around Europe;
3. A practical toolkit made up of key legal aspects and issues related to the protection of migrants and refugees' rights at the European level, knowledge of existing funding opportunities, and project design and management
4. A solid grounding for future follow up studies, projects and activities in the area of migration and asylum.
